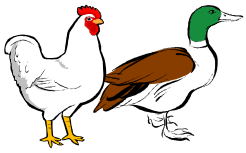

Important Notes, Terms & Conditions of Sale Spring Show & Sale - Saturday 3rd March 2012

ENTRY

- ▶ All entries must be received on this official entry form with the £2 per pen deposit by Friday 24th February.
- ▶ Absence of this form or incomplete information may result in late or incorrect payment.
- ▶ TRIO – one male & two females, PAIR – one male & one female

SALE DAY – DELIVERY OF LOTS

- ▶ Delivery of poultry & hatching eggs is strictly on the day of sale, 6.30am till 8.45am.
- ▶ The Auctioneers reserve the right to refuse entry.
- ▶ The market will also be open for delivery of poultry equipment on Friday 10am till 4pm.

SALE DAY - GENERAL CONDITIONS OF SALE

- ▶ All Birds must conform to breed standards where applicable.
- ▶ All breeds of birds are acceptable.
- ▶ The legislation relating to the Poultry Breeding Flocks and Hatcheries (Registration and Testing) Order will NOT apply at this sale.
- ▶ All legislation relating to fowl pest and the sale/transport of live Poultry will apply as usual.
- ▶ Further information regarding the Registration and Testing of laying flocks can be obtained from the Regional Ministry of Agricultural Veterinary Officer.
- ▶ There is no Ministry requirement to segregate salmonella tested birds from untested birds – nor is there any guarantee by the Auctioneers as to the health status of any lot.
- ▶ **All birds must be carried in boxes**, no birds shall be carried in sacks.

SALE DAY - VENDORS NOTES

- ▶ All lots are accepted into the Market entirely at the Vendors risk.
- ▶ It is the Vendors responsibility to ensure the auctioneers have the correct description for the contents of the pen.
- ▶ The Auctioneers hold no responsibility for the descriptions collected from the vendors.
- ▶ The sale will take place in catalogue order.

SUBSTITUTED LOTS

- ▶ Lots which are substituted after the catalogue is printed will result in the £2 deposit being withheld

VENDOR COMMISSION RATES/ENTRY FEE

- ▶ 15% Commission or minimum of £1.75 per a lot will be charged on all lots sold.
- ▶ **A deposit of £2 per pen/lot will be paid with the entry form. This deposit shall be returned with the vendors payment after the sale unless the lot is not sold or not forward.**

PURCHASERS NOTES

- ▶ At the fall of the hammer all lots remain in the Market entirely at the Purchasers risk.
- ▶ A Purchasers commission of 5% + VAT will be charged on all purchases in this section.

VALUE ADDED TAX – VAT

- ▶ No VAT on birds.
- ▶ The VAT status of lots (equipment, arks & accessories etc) will be announced by the Auctioneer at the time of sale. VAT at the standard rate will be charged where applicable.
- ▶ In the absence of any specific instructions on VAT status, VAT will be charged.

SALE DAY - COLLECTION OF LOTS

- ▶ All birds must be cleared from the market by 6pm on the day of sale.
- ▶ All Purchasers must obtain a receipted 'Pass Out' obtainable from the main office upon settlement of their account. The pass will have to be presented to the CCM staff at time of collection.
- ▶ Payment will be withheld by CCM until all unsold lots are removed by the Vendor.
