Important Notes, Terms and Conditions

Delivery of Lots

The Market will be open for delivery of lots as follows:-

Thursday 2.00pm – 4.00pm., and Friday 10.00am – 4.00pm preceding the Saturday Auctions. (See Loading/Unloading Services below)!

Saturday morning up to 9.00am goods must be lotted by 9.30am.

To assist Market Staff, please indicate on entry form, where possible, day and time of delivery.

ONLY LOTS 'DELIVERED' & 'LOTTED' into the Sale, by the Friday at 4.00pm, will be included on the Lotted Sales List.

CCM Staff may exercise their right to refuse to accept any lot for Sale.

Loading/Unloading Services

A Loader vehicle will be available free of charge Friday 10.00am-4.00pm preceding the Saturday Auctions, until 5.30pm Saturday. **(YARD CLOSED SUNDAY)** The loading/unloading facility is provided entirely at the risk of the Vendor or Purchaser. The Vendor/Purchaser will be responsible for supervision of loading/unloading, CCM Auctions accepting no liability.

Vendors Risks

All lots are accepted into the Market entirely at the Vendors risk.

Purchasers Risks

At the fall of the hammer all lots remain in the Market entirely at the Purchasers risk.

Keys, Documents, Etc.

Any such items should be CLEARLY MARKED and handed in to Market Staff for safe keeping, on delivery of the lot to the Auction Mart.

Electrical & Upholstery

Electrical items will only be allowed into the Auction if accompanied by a up-to-date Test Certificate.

All Upholstered Furniture entered into the Auction must display an approved safety label/logo.

Value Added Tax – VAT

The VAT status of lots will be announced by the Auctioneer at the time of sale. VAT at the standard rate will be charged where applicable.

In the absence of any specific instructions on VAT status, VAT will be charged.

Commission Rates/Entry Fees

Commission will be charged to the Vendor on each lot as follows:-

10% Commission UP TO £1000, OR 5% Commission OVER £1,000, OR 3% over £2,000 OR £1.50 per lot minimum. An entry fee of £1 per lot charged on all lots.

Buyers Commission of 10% – VAT applicable ON FURNITURE SALE ONLY

Collection of Lots–ALL LOTS BOUGHT & UNSOLD TO BE COLLECTED SATURDAY

All Purchasers must obtain an authorised passout, before lots are removed from the Market. Payment will be withheld by CCM until unsold lots are collected. A storage fee will be charged for unsold/sold lots if not collected.
